Guilbeau Park Owners Association is an association of property owners organized pursuant to the Declaration of Restrictive Covenants and Conditions of Guilbeau Park, Unit II, executed April 3, 1984, recorded in Volume 3127, Page 690 and re-recorded in Volume 3894, Page 1223. Official Public Records of Real Property of Bexar County, Texas, as amended by the Supplemental Declaration of Restrictive Covenants and Conditions of Guilbeau Park, Unit III, executed on September 5, 1984, recorded in Volume 3232, Page 1537, Official Public Records of Real Property of Bexar County, Texas, as amended by the Amendment to Declarations of Restrictive Covenants and Conditions of Guilbeau Park, Units 2 and 3, executed on May 20. 1985, recorded in Volume 3409, Page 1384, Official Public Records of Real Property of Bexar County, Texas, as amended (hereinafter referred to as "The Declaration")

Whereas the City of San Antonio has deemed Short Term Rentals a commercial business operation and requires the payment of Hotel and Motel tax;

Therefore the Guilbeau Park Owners Association recognizes Short Term Rentals as commercial operations if less than 30 days (excluding month-to-month lease extensions) and therefore prohibited to operate within the confines of the Association according to the Deed Restrictions of the Association, paragraph 7.17, Prohibited Activities.
